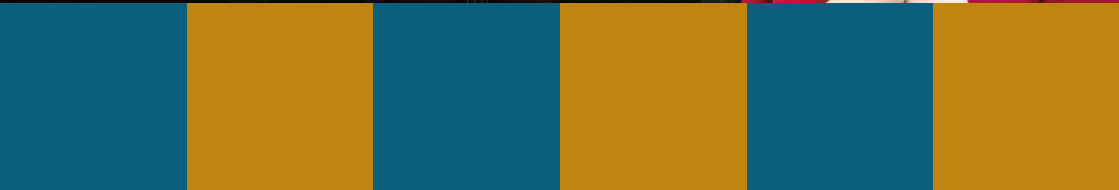

## OVERTURE £50

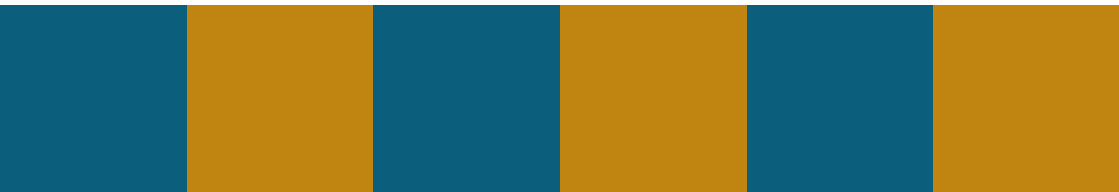
Overture supporters will receive:
